

Information on enrollment in compulsory school attendance - school year 2021/2022

In connection with the anti-epidemic measures which affects this school year, the Ministry of Education, Youth and Sports has issued measures to organize enrollment for compulsory school attendance in the school year 2021/2022 so as to guarantee the safety of children and adults, respect the individual possibilities and restrictions of individual participants. At the same time all legal obligations to have been fulfilled. Enrollment will take place without the personal presence of children at school.

Enrollment for compulsory school attendance will take place at schools established by the city of Mladá Boleslav in accordance with legal regulations, but with the abandonment of some traditional procedures. It will take place in accordance with the Education Act **from the 1st until the 16th of April 2021.**

The legal representative will visit the school's website, click on the "**Online enrollment**" link and a form will appear. Fill in the necessary personal data, including contact information. This form is then immediately automatically sent to the school system.

After filling the form, the legal representative will complete the formal part of the registration by signature. The legal representative will print out the completed .pdf file and submit the signed form to the school together with a copy of the child's birth certificate and a copy of the permanent (long-term) residence permit (if you are a non-EU citizen):

- a) Personally - Mondays and Wednesdays (8: 00-11:30), or at another date arranged by phone with the school administration
- b) By post (the date of submission to the post office is decisive) – use certified mail
- c) Data box
- d) Email with the electronic signature of the legal representative

** In case the legal representative does not have the opportunity to print the form, he/she will make an appointment at school in advance to have this form printed directly there.*

2) If the legal representative does not have the option of "Online enrollment", after a telephone agreement with the school he arranges a personal visit to the school, where he **fills in the form** of enrollment in primary school without the child's presence and gives the school **a copy of birth certificate and a copy of permanent (or long-term) residence permit (if you are a citizen of a country outside the EU)**

Every child who reaches the age of 6 by 31 August 2021 applies for registration. Children who turn 6 years from September to the end of December 2021 can be admitted on the recommendation of a school counseling facility. Children who turn 6 years old from January to the end of June 2022 can be accepted on the recommendation of a school counseling facility and a specialist.

The child's legal representatives may choose a school outside the designated school district. However, children with a place of permanent residence in the school district are **preferably** admitted, up to the amount of the permitted number of pupils listed in the school register. School districts are determined by the General Binding Decree No. 1/2018, which can be found on the website of the city of Mladá Boleslav.

If the child is not physically or mentally mature after reaching the age of 6 and if the legal representative so requests in writing at the time of enrollment, the school principal will postpone the start of compulsory schooling by one school year. The legal representative must submit a

recommended assessment of the school counseling facility and a specialist doctor or clinical psychologist together with the application.

If a child has already been granted a postponement of compulsory schooling, he or she is not automatically admitted to the following school year to the same school. The legal representative must apply for admission to compulsory schooling again next year. It has to be applied for at a different school than the previous one.

The principal decides on admission to compulsory school attendance. The list of admitted children will be published in a publicly accessible place at the school and on the school's website. The decision not to admit will be delivered to the legal representatives within the legal deadline. It is possible to appeal against the decision of the school principal to the regional authority through the school directorate, where the request was not granted.
